MESSAGE FROM THE CHIEF

Clovis Police Department had substantial dynamic changes in 2015, due to retirements of personnel. The men and women of this organization continued to perform at the highest level; the following information is the highlights of the activity and accomplishments by our agency for the past year.

The department's staffing of personnel averaged 57 sworn officers over the twelve month period. The dispatch center continues to function with an average staff of 13 Telecommunicators handling 145,297 incoming and outgoing calls to the center. A total of 5,790 calls were received on the E-911 lines and 33,670 calls were received by the wireless (cell phone) 911 system.

In 2015, the department responded to a total of 41,092 calls for service and we completed 8,157 incident reports. In 2014, the department responded to 41,685 calls for service and completed 7,767 incident reports. This reflects a 1.42% decrease in the calls for service and 5.02% increase change in the number of incident reports from the previous year.

The officers made a total of 1,963 arrests for 2015. Of these arrests, 399 of them resulted in felony charges.


The department's successes can be measured in the amount of crime reported in Clovis. In 2015, we saw a decrease in our Indexed crimes. This includes the categories of Homicide, Rape, Robbery, Aggravated Assault, Burglary, Larceny and Motor Vehicle Thefts. The 2015 Index Crimes decreased 20% in comparison to 2014.

The Special Operations Unit (SOU) produced a 39% clearance rate for 2015. The SOU was assigned 418 cases in 2015. The Detectives cleared 165 of these cases by arrest or other exceptional means. With the team work of Patrol and Investigations, these numbers are well above the national average.

The Major Crimes Unit was activated on two occasions in 2015. These incidents involved homicides where one occurred in Clovis and the other was in Portales.

The department organized and implemented three community events. Kops-n-Kids Basketball, National Night Out and Kops-n-Kids Christmas. None of these events would have been achievable without the men and women of the Clovis Police Department.

Therefore, I want to say "Thank You!" to all the employees for their hard work and dedication to providing ethical and professional policing services to our citizens.

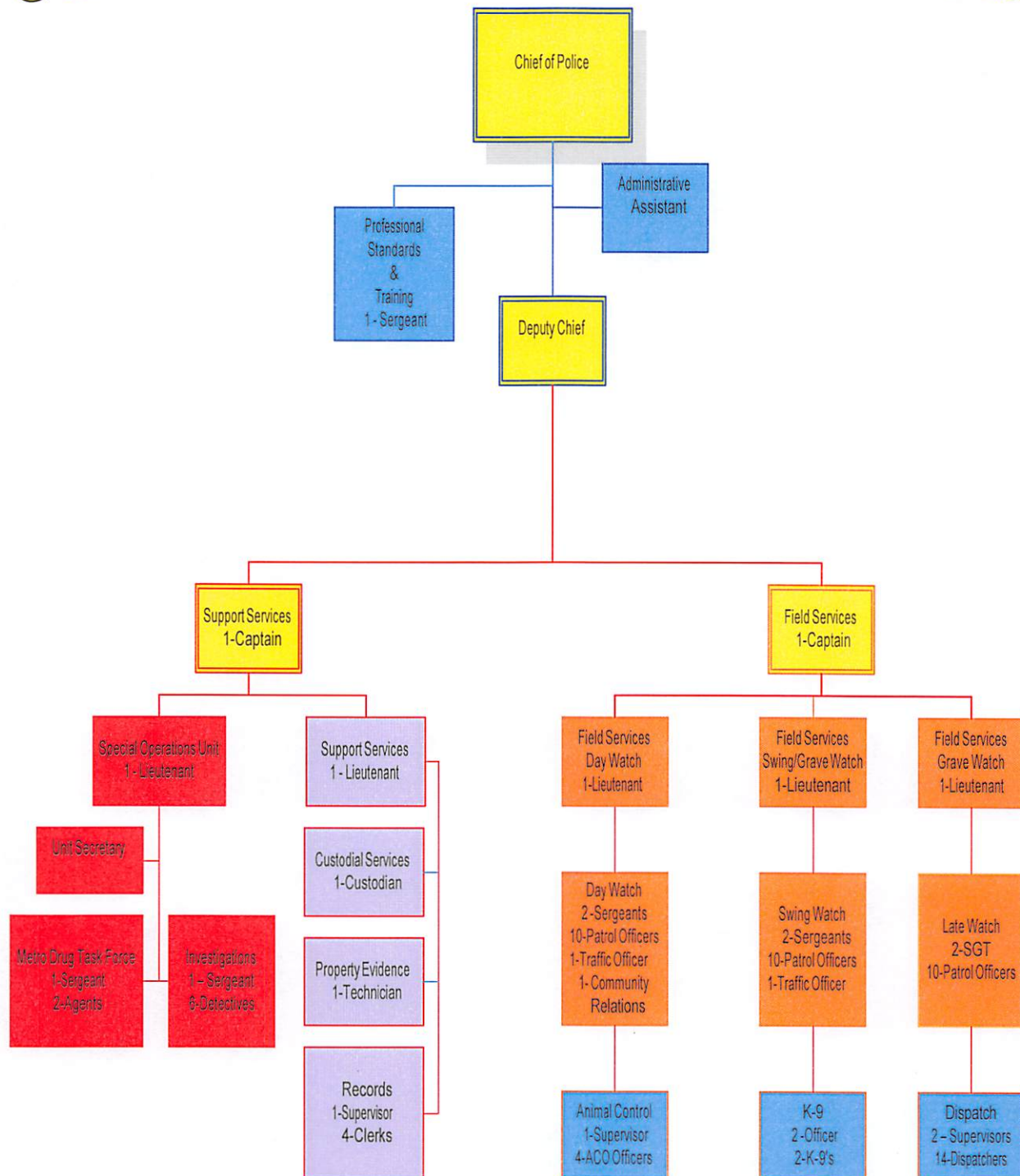

UNIFORM CRIME REPORTING

The Uniform Crime Reporting Program classifies offenses into two groups, Part I and Part II crimes. Each month, the department submits information on the number of Part I offenses (Crime Index) reported to us. Those offenses are cleared by arrest or exceptional means; and the age, sex, and race of persons arrested. We provide only arrest data for Part II offenses.

The Part I offenses, which comprise the Crime Index because of their seriousness and frequency, are defined below:

Criminal Homicide — Murder and non-negligent manslaughter: The willful (non-negligent) killing of one human being by another. Deaths caused by negligence, attempts to kill, assaults to kill, suicides, and accidental deaths are excluded.

Rape/CSP of Minor — The carnal knowledge of a female/male forcibly and against her/his will. Rapes by force and attempts or assaults to rape, regardless of the age of the victim, are included. Statutory offense (no force used – victim under age of consent) are excluded.

Robbery — The taking, or attempting to take, anything of value from the care, custody, or control of a person or persons by force or threat of force or violence and/or by putting the victim in fear.

Aggravated Assault — An unlawful attack by one person upon another for the purpose of inflicting severe or aggravated bodily injury. This type of assault usually is accompanied by the use of a weapon or by means likely to produce death or great bodily harm. Simple assaults are excluded.

Burglary — The unlawful entry of a structure to commit a felony or a (breaking or entering) theft. Attempted forcible entry is included.

Larceny-Theft — The unlawful taking, carrying, leading, or riding away of (except motor vehicle theft) property from the possession or constructive possession of another. Examples are thefts of bicycles or automobile accessories, shoplifting, pocket-picking, or the stealing of any property or article which is not taken by force and violence or by fraud. Attempted larcenies are included. Embezzlement, confidence games, forgery, worthless checks, etc., are excluded.

UNIFORM CRIME REPORTING

Motor Vehicle Theft — The theft, or attempted theft, of a motor vehicle. A motor vehicle is self-propelled and runs on the surface and not on rails. Motorboats, construction equipment, airplanes, and farming equipment are specifically excluded from this category.

FIELD SERVICES

The Clovis Police Department's Field Services Division is comprised of the Patrol, Dispatch, Traffic and Major Crash Unit, K-9, Gang Unit and Animal Control. There are thirty-five officers and ten supervisors responsible for the day-to-day response to calls for service. While the Animal Control Unit is comprised of four officers and a supervisor.

911 COMMUNICATIONS CENTER

The Clovis Police Dispatch Unit has a staffing allocation of 16 dispatchers with two of the slots being shift supervisors. The unit is responsible for the emergency radio communications and has been designated a Public Service Answering Point (PSAP) for Curry County. We currently have two (2) dispatchers in the dispatch training program.

Telecommunicators handle a wide variety of tasks during their shift. Ranging from answering phones, emergency medical dispatching, call entry, warrant confirmation, NCIC(National Crime Information Center) database inquiries, state database inquiries, and have the responsibility of knowing where their police officers and fire/EMS personnel are at all times.

Telecommunicators must have multi-tasking capabilities.

The Dispatch Unit provides radio capabilities for the following agencies:

- ◆ **Clovis PD**
- ◆ **Clovis Fire/ EMS**
- ◆ **Texaco Police Department**
- ◆ **Curry County Sheriff's Office
(After hours and on weekends)**
- ◆ **Animal Control**
- ◆ **Clovis Public Works (after hours)**

911 COMMUNICATIONS CENTER

The Dispatch Unit also provides 24 hour communication services for the Melrose Fire, Field Fire, Grady Fire, Broadview Fire, Texaco Fire, Pleasant Hill Fire, and CAFB (Canon Air Force Base)/ EMS (Emergency Medical Services). The Clovis Police Department Dispatch monitors LEN(Law Enforcement Network)/ State Police Channel, State Fire 1 & 2, the PRMC (Plains Regional Medical Center) Channel, and the State Medical Channel.

The Dispatch Unit answers the emergency (911 Calls) for the county and the non-emergency calls for the Clovis Police Department. The Unit has upgraded to handle wireless 911 calls and has the capability to map incoming wireless (cell phone) 911 calls throughout the county.

In 2015, the unit answered 145,297 inbound calls. Of the 145,297 calls, the Unit answered 5,790 E-911 calls for service. There were 33,670 calls for service which came from the wireless 911(cell phones) system. The Unit answered 69,750 administrative calls providing a variety of information to the callers.

TRAFFIC UNIT

The Clovis Police Traffic Unit has the responsibility of providing traffic crash investigation, DWI (Driving while intoxicated) and traffic enforcement. This is done with the use of police cars and motorcycles equipped with Radar and Lidar systems.

Members of the unit have received a variety of very specialized training preparing them to investigate auto and pedestrian traffic crashes. They have received enhanced training in detecting and processing DWI investigations.

The Clovis Police Department wrote a total of 9,567 traffic citations for 2015, while the department investigated 1,376 traffic crashes. Of the 1,376 crashes, 173 of these crashes involved an injury.

The department utilizes a grant from the State of New Mexico to address the traffic and DWI enforcement issues. In 2015, the department arrested 111 drivers for DWI. Of the 111 drivers, 56 drivers were charged with aggravated DWI, while 4 of the drivers were charged with felony DWI. The average breath alcohol level in 2015 is .16 BrAC (Breath alcohol content).

The department did investigate a total of 15 crashes in which alcohol was a factor in the collision.

MAJOR CRASH UNIT

The Clovis Police Major Crash Unit has the responsibility of providing technical traffic accident investigation for major crashes within the city. This is done with the use of laser measuring devices and specialized equipment.

Members of the unit have received a variety of very specialized training preparing them to investigate and reconstruct auto and pedestrian traffic crashes. This allows officers to analyze, evaluate and determine the causation factors associated in the collision. Major Crash Unit Officers prepare reports with visual aids and later present these cases to the courts as expert witnesses.

The Traffic Unit and Major Crash Team investigated one fatal crash this year and were activated to investigate four other major collisions within the city limits of Clovis.

1. **15-02637:** Female driver travelling east on Brady with one passenger at a high rate of speed. Driver lost control causing her to strike a utility pole on the south side of Brady. The driver was ejected from this vehicle and sustained major traumatic injury rendering her in a vegetative state to this date. The driver was under the influence of alcohol and the DWI charges are pending her recovery which is not likely to happen. The passenger in this crash was still in the vehicle at final rest and sustained injury from this crash but has since recovered.
2. **15-03812:** This crash involved only the driver. The male driving a 2001 Ford sedan was driving erratically in the area of Edwards and 12th street. The driver was east on 12th and crossed Edwards where he lost control at a high rate of speed. The vehicle crashed into a large tree on the east side of the property at 1201 Edwards. The driver was not wearing a seat belt, and subsequently died at the scene from the injuries he sustained in the crash.

MAJOR CRASH UNIT

3. **15-05340:** This crash involved two vehicles that were north on Prince Street at a high rate of speed. Vehicle 1 lost control at Prince and Sunset causing it to strike a utility pole which broke it in half. Vehicle 1 continued across Sunset striking wall in the north side of Snyder's Cleaners. The vehicle had heavy damage to the front and both sides. The driver of vehicle 2 said he was following vehicle one to hospital due to a deep cut on drivers #1 wrist. Driver #2 said when his friend crashed into the utility pole he swerved to miss and hit landscaping at 3301 N. Prince. Driver #1 was taken to the hospital for treatment of his injuries to his wrist and later recovered.
4. **15-05394:** This crash involved a small vehicle and a motorcycle. The vehicle involved was at an address on the west side of Prince across No Name Street. The driver said he backed out of the address drive and went to turn around to travel north on Prince. The driver of this car did not see the motorcyclist travelling south in the inside lane. The car turned across the path of the southbound motorcycle. The motorcyclist struck the left side of the car and was vaulted off of the motorcycle into the north bound lanes of S. Prince. We had the medical helicopter land at the scene on S. Prince to air lift the motorcyclist to Lubbock for treatment. The driver of the car was not injured. The driver of the car was cited for turning in front of the motorcyclist. The motorcyclist later recovered from his injuries.
5. **15-06269:** This crash involved two motorcycles and a passenger truck. The rider of the first motorcycle was attempting to catch up to his buddies from Grand travelling north on Prince. The other riders had stopped for a train and were sitting stationary at the railroad tracks behind the passenger truck. The motorcyclist who was travelling north was travelling a high rate of speed and upon braking could not stop. The motorcyclist used almost all rear braking sliding over 200 feet until colliding into the rear of his buddy's motorcycle in the outside portion of the north bound outside lane. The rider that was struck as well as vehicle #1's operator was transported to medical facilities for treatment. All involved are expected to fully recover from this crash.

K-9 UNIT

The Clovis Police Department currently has one K-9 team, which comprise the K-9 Unit. K-9 Leo is partnered with Master Police Officer Brent Aguilar. B. Aguilar and K9 Leo logged 253 training hours with 98 of those hours being scheduled monthly training days.

Having only two K9 teams in the Clovis/Curry County Community, Adlerhorst International pulled Master Instructor Ed Nicks from the Clovis rotation and the Clovis PD K9 team was required to travel to Midland, TX once in 2015 for bi-monthly training.

ANIMAL CONTROL UNIT

The department hired 3 new officers in 2015. Two of the three hired have received their New Mexico Euthanasia Technician license.

The department lost 2 officers in 2015, Michael Foshee and Matt Kinder resigned in August to begin career in truck driving.

The shelter received a new animal control unit. The 2015 Ford F-250 had the Swabb Animal Mobile installed with all the latest standard equipment. Cameras were installed in the cat room in December to help monitor customers and workers in the room.

The Animal Shelter's drug audit was performed in May by Dr. Hudson of All Pet's Animal Hospital. The overall score was a superior rating based on the record-keeping by the officers.

SPECIAL OPERATIONS

The Special Operations Unit (SOU) is the department's investigation unit and is currently staffed with 5 full time detectives and a Detective Lieutenant. The SOU continues to receive a large number of cases assigned. The detectives are responsible to investigate a variety of crimes, which may include residential, commercial and auto burglary cases, sex crimes, sex crimes against minors and white-collar crimes. The unit is currently staffed with 5 Full-Time Detectives. The SOU was assigned 418 new cases for the year of 2015. Of the 418 cases, 165 cases were solved giving the unit a 39% overall clearance rate. The clearance is based on Arrests, Warrants for arrest, and cases that were Exceptionally Cleared and this total does not include the unfounded cases (34), the Inactive cases (111), or the Active cases (108).

SOU investigated one homicide in March of 2015. MCU-(Major Crimes Unit) (was activated in late June 2015 and a Murder arrest warrant for David Gutierrez was served on July 21, 2015 for the 2002 Cold Case Homicide of Jose "Chico" Valverde. Members of SOU were activated as part of the Major Crimes Unit for a homicide investigation in Portales In November. Both investigations led to the arrest of suspects who are currently awaiting trial. One missing person report was forwarded to SOU. The missing person, Richard Odom, was ultimately discovered in a field. No signs of foul play were noted. We are awaiting more information from OMI (Office of Medical Investigation) on a child abuse resulting in death case (Noah Trujillo). SOU and R5DTF (Region V Drug Task Force) also acted on an investigation into human trafficking at massage parlors in Clovis and Portales. Information from this case was relayed to the State Attorney General's Office.

There were 725 Burglary Reports taken in 2015 by Patrol, which is -3% less than the 748 reported in 2013, 84 Burglary cases were assigned to the Detective Division from January through December 2015.

RECORDS UNIT

The Records Unit has had a busy year. During 2015 the Records Section received a facelift, replacing flooring, minimizing clutter, and arranging the working area to be more hospitable for the section.

The Records Unit is the information hub and holding center for the public records of the Clovis Police Department. The unit consists of four clerks and a supervisor who handle all of the incoming requests of incident/accident reports, court dispositions, background checks and fingerprints and by the end of 2015 was down one employee. The unit received 2,816 official requests for documentation pursuant the New Mexico's "Inspection of Public Records Act." The unit also responded to 1,396 requests for discovery from the District Attorney's Office and various defense attorneys

In 2015, the Records Unit utilized the department's records management system, CAPERS (Compute Aided-Dispatch & Record Management Systems). The unit is responsible for the recording and archiving of all the police records. In 2015, the unit recorded 7,767 Incident reports and 1,276 accident reports.

The Records Unit also provides the officers with a transcription system in which the officers are able to dictate the narratives of their reports and the Records Unit transcribed them into the RMS system.

The Records Unit processed 10,039 citations and entered 1,192 warrants into the N.C.I.C. (National Crime Information Center) system. The Records Unit fulfilled 1,959 requests for various other services and generated \$18,005.10 in fees.

SWAT

The Clovis Police Department had two full team activations and one partial-activation in 2015. Following is a brief synopsis of the year's activations.

The three activations for the Clovis Police Departments SWAT (Special Weapons and Tactics) were all barricaded subject calls. All situations were involving a weapon or a report of weapons in the possession of the subjects.

- ❖ The first activation for the year was on March 11, 2015 at 912 Pecos St. for a barricaded subject. The suspect in this incident was wanted on felony warrants and when contacted by Officers, he ignored commands, entered the residence and barricaded himself within the residence. A full activation of SWAT and CNU were utilized and the subject conceded and gave himself up without the incident escalating.
- ❖ The SWAT Team had a partial activation on August 5, 2015 at about 1630 hours. A subject wanted for larceny from a local gun shop, barricaded himself inside the residence at 1004 E 10th St. with a knife. This situation was resolved as members from the SWAT Team began arriving to the scene. This situation was resolved peacefully and very quickly,
- ❖ The final full team activation for 2015 was on December at 701 W 21st St. (Mirador - Apartments). This situation was a barricaded subject stemming from a domestic assault resulting in threats of harm with a gun to small children. Once the team was activated after several hours the suspect did give himself up to police and the situation was resolved peacefully.

The SWAT team had no officers added to the team during the 2015 annual training cycles. The team did however suffer losses of members to promotion (Captain Romero) and resignations from the organization.

Our team had several unique trainings during the past year. With the changes at the Hotel Clovis and constant occupancy; the team had an opportunity in February to meet with the SERE Group at Cannon Air Force Base and conduct Rappel Training. This training included the use and inspection of rappel harness, how to properly fit the harness and actual rappel exercises with no gear graduating to full gear down a four story platform. While in full gear, this included all weapons systems carried by members of the team.

Our team received new tactical helmets and replacement ballistic panels for the body armor in use as the previous armor was expired and old. The equipment was purchased by Federal Grant Funds. During the purchase of this equipment, the Clovis Police Department was required to submit paper work in order to have a classification typing assigned to the team for eligibility of Grant funds. The team was classified as a Type III team with qualifications as a non-full time team.

SWAT

During 2015, officers trained in subjects that are not visited very often such as: Officer Down, Officer Rescue drills and open range movements. Officer Down and Officer Rescue were conducted incorporating use of the Clovis Police Department SWAT vehicle. This included best practices for loading injured personnel into the SWAT vehicle for extraction to safe locations for treatment. Training was primarily at the Curry County Fair Grounds and Ned Houk Park as these venues provided lots of options for training variables.

In August, team members were asked to participate in DHS (Department of Homeland Security) training. This familiarized team members with cross training with CFD (Clovis Fire Dept.) and CAFB (Canon Air Force Base) personnel in biological and terroristic situations. It was good to see the communication hurdles and triumphs we encountered with these scenarios. It put our operators in a hazmat environment with potentially violent confrontations. This meant the utilization of air packs. This was a difficult but achievable scenario for our team.

The Team did not train during the months of April and December in 2015 because of conflicts with holidays and other trainings department wide.

During 2015, the decision was made to have the Clovis Police Department Sniper Element meet each month and conduct separate training from the Tactical Entry Unit. We began this on a weekly basis to see if the training regiment would be compatible and how effective this would be. Because of conflicts with training and shift shortages, the Sniper Element was not able to meet each month.

The Sniper Element is comprised of three snipers, a team leader and two snipers. Each member of the Sniper Element is required to make an effort to fire a single cold bore deviation round at least two times a month with a weekly cold bore preferred. The purpose is to maintain rifle data, weather and element effects on bullet and bullet trajectory at different distances and lighting effect.

During the past year the Sniper Element met for training a total of 17 times spending 31.5 hours on specific training related to long range precision and positional shooting. This included firing cold bore deviation rounds, qualification courses and decisional shooting. There were a total of 131 cold bore deviation rounds fired during 2015.

PROPERTY/EVIDENCE UNIT

The Property and Evidence Unit continues to be operated with great efficiency by Mr. Wendell Blair. The total number of pieces of evidence received into evidence in 2015 was 3,770 pieces of physical property and an additional 5,652 pieces of digital evidence entered into the DIMS (Digital Imaging Management System). Throughout the year, the Evidence Unit transitioned 16,981 pieces of evidence to the courts, labs, storage, and to individuals. The evidence Unit destroyed 1,746 through court orders during the year, 58 items were transferred to other agencies, and 291 items were returned to their rightful owners in 2015.

There were some significant events for Property and Evidence in 2015. Lockable linear filing cabinets from the Records Section were repurposed for firearm storage in Evidence. The Evidence Unit passed inspection during our accreditation process, with no discrepancies noted by the inspectors. At the end of 2015, after consulting other agencies using the BEAST(Integrated Evidence Tracking System), were shown a way to combine long term storage properties (murder cases, rape cases) into a singular bar code for tracking. This discovery, once fully implemented, will assist the Evidence Unit in more efficiently conducting inventories.

PROFESSIONAL STANDARDS UNIT

The Professional Standards Unit is responsible for the internal affairs, staff inspection and the training and recruiting functions within the Clovis Police Department.

The Internal Affairs Section conducts and coordinates the investigations of allegations of misconduct on the part of Department employees. During 2015, four (4) internal investigations were processed.

The Staff Inspection Section conducts inspections of all organizational components within the Department, ensuring compliance with New Mexico State Chiefs of Police Association Accreditation and Department policies and procedures. There were a total of four (4) quarterly random inspections of the Property/Evidence room. The unit also conducted an annual 100% audit of the firearms, narcotics, money and jewelry secured in the property/evidence room. During all inspections/audits, no discrepancies were noted.

In 2015, the Recruitment Unit conducted the required testing and background processes for a total of twenty-eight (28) personnel. We hired fourteen (14) new police officers, three (3) animal control officers, two (2) records clerks and six (6) telecommunicators and one (1) administrative assistant.

The Training Unit conducted a forty-hour (40) hour annual in-house training program to meet the biennium training requirements set forth by the New Mexico Department of Public Safety. The department also is providing additional training through the use of a web-based software called the V-Academy. The officers and staff completed a minimum of eight (8) on-line courses concerning a variety of different courses.

The unit hosted a Field Training Officer School, which qualified four (4) Clovis Police Officers as Field Training Officers.
