Greetings! 2021 started off promising change for the City of Clovis Police Department but we had no idea the impact the changes would have. One of the first things Chief Doug Ford did was decide to have a Deputy Chief to assist him with the operations of the Department.

The year began with personnel shortages in all Divisions, from Animal Control, Records, Dispatch, Patrol and Detectives to Narcotics. The close of the year did not seem much better. Some of the shortages were blamed on salaries, stress from the COVID-19 Protocol on handling calls not to mention the fear of exposure to COVID-19.

The members that remained employed with the Department stayed strong and even with all of the preventive methods utilized, a few members still became ill. This caused additional stress to the officers because they did not know what they were exposing their families and friends to. Luckily, the threat of the disease ebbed towards the end of the year and some things were returning to normal, whatever that is going to be.

In February, Chief Ford selected Officer Roy Rice, Community Relations Officer to be his Deputy Chief. As DC, I was looking forward to helping Chief Ford with the operations for three years or so. It was a surprise when Chief Ford made the announcement of his retirement the end of December.

We were working on getting the Department staffed so the already exhausting employees could get as break and get some rest. This effort seemed futile since we would put a new employee on line and one or two members would announce their separation from employment. Some of these separations were caused by the military spouse being transferred, but none the less, the already over worked Department was feeling the strain as well as the Chief of Police. The Department was in dire need of people and no one was applying or was able to pass the testing requirements.

Staffing seemed the most difficult part of the job but the real purpose of our responsibilities was keeping us busy as well. There were five homicides this year with three in March, April, May and then end of the year with two more in October and November. While not dealing with homicide investigations, the officers were working family and neighbor disturbance calls. I will show all of the calls and reports in the appropriate sections.

Though it is easy to concentrate on the negative events and the negative attitude of the nation and State Legislation towards law enforcement in general, we recognized how much the citizens of the city appreciated the police and the people working here. We were told by the public how much they appreciated our service, they brought food, snacks, water, decorated the lobby glass with stars and letters, and overall, smiled and shook the employees' hands. Quite the opposite of what we were hearing on the national media and social media.

Vehicle shortages brought about a change in the color of the vehicles were driving. We were only able to get black vehicles to replace the aging and worn fleet of white sedans. These units were placed in specialized assignments in order to keep the patrol fleet uniform in appearance.

With the lifting of the COVID restrictions, we were able to get back to some normalcy with our Public Relations events. Though not able to do the Coffee with Cops, we were able to put together our big event for the year, Cops and Kids Christmas. With this were the fund raisers of Donuts for Dollars and Leal's Cops and Tips. This event was a much-needed event for the officer's and employee morale, not to mention the community.

We closed the year with the Annual PD Christmas and Awards Banquet which was provided by a local bank and Church. Then there was Chief Ford's Retirement and wishing him the best in his and Jane's travels. Chief Ford deserves a lot of credit for bringing the Department through a very rough time of shortage in manpower, changes in legislation, and COVID. It was an honor to work for him and serve beside him the past ten months. He has earned the retirement of his dreams and I wish them much happiness.

As for the next year, we have hopes for a better year and wondering what changes it will bring.

Thank you for allowing us to serve this community.



## PATROL DIVISION

This the unit that patrols the streets, handle calls of service, traffic enforcement and first responder to almost anything the Department receives.

This unit is made up of a diverse fleet of sedans, SUVs, pickups, and motorcycles. These officers are uniformed and plainly visible as police officers.



The Patrol Division started off the year with low numbers, 30 officers out of an authorized strength of 43 in the Uniform Services. And the numbers kept dwindling to the close of the year with only 29 officers and the prospect of losing 3 after the first of the year. The year only brought in a few applicants and very few applications. It seemed like the department was fighting a losing battle with personnel shortages in every Division, but the Department held strong, the men and women stepped up to the challenge and continued taking care of the community.

#### Traffic Unit

The traffic unit is staffed with two Master Police Officers, Kroeger and Heldt. Their primary role for the agency is traffic enforcement. Whether it is on the marked police motorcycle or in the stealthy marked sedan or SUV, they work the traffic problem areas, work the traffic accidents, DUI's and will back up and assist on calls as needed.

A new member of the Patrol Division has been trained in DRE (Drug Recognition Expert) to assist the Traffic Unit with the DUIs. They are making a good team and anticipating this unit to be a big safety asset to the department.



## Crash Team

The Clovis Police Department Crash Team is made up of officers from the Traffic Unit, Detectives, and Patrol Officers who have chosen to be called out to investigate vehicle crashes that are fatal or could result in a fatality. These officers are on call 24/7/365 and have demonstrated their ability to investigate, photograph, measure, and document a crash scene. They have members trained in reconstruction of a crash and determine the cause of the crash and testify in court when needed.

## **DWI Statistics**

The CPD participates in the ENDWI program and conducts DWI Checkpoints periodically. The Patrol Division and the Traffic Unit are utilized to combat impaired driving with several officers certified to conduct breath intoxilyzer exams. To augment the intoxilyzer, we have an officer trained and certified as a Drug Recognition Expert (DRE). His role is important when dealing with persons that are impaired by something other than an intoxicating beverage such as illegal drugs.

## Police Service Dog (K-9) Unit

The Clovis Police Department began the year with two fully functional K-9 Units. MPO Jordan Riddle and her PSD Castor and MPO Jesus Sarabia with his PSD Skipper. Both units were performing well and utilized on vehicle searches, building searches and called in to assist with search warrants. Early in the year PSD Castor was being utilized to subdue a suspect and the suspect drove off and drug PSD Castor a distance causing him bodily injury. The wounds were treated and he healed and was returned to service.

A couple of incidents occurred later in the year that removed PSD Castor from service. First incident occurred at Ned Houk Park while the K-9 Teams were conducting training and PSD Castor bit a citizen. The citizen was not involved in the training and though not seriously injured, there were punctures to the skin made by Castor.

A couple of months later, PSD Castor was involved in another incident where a child was bitten. This K-9 Team was taken out of service permanently with MPO Riddle returning to patrol duties.

## Special Weapons and Tactics

As with all of our specialized Units, they are made up from the sworn officers that hold other positions within the Department. The Team Commander Trevor Thron is also a Lieutenant of the Investigations Division and he supervises the Team along with the Team Leaders Lt. Chet Gurule and Lt. Dago Rodriguez. At this time the Team has six team members and as the Department rebuilds its personnel strength, then the Team will be added to.

These officers are specially trained and train often to keep their skills. They have tools that assist them in their role to protect the public and maintain peace. The MRAP, the most obvious tool in the arsenal is the armored vehicle obtained from the military. Other than weapons, the Team also has a versatile robot that can be used to make entry to a residence or approach a building. It can be utilized to search a building instead of putting officers in harm's way.

#### Communications

Usually, our most solid staffed Division of the Police Department, this unit went through some tough months with the shortage of personnel that the shifts were being covered by sworn police officers from officers up to and including the Chief of Police. Thankfully the Fire Department has sent people over to assist us through this time of need. This manning the stations with police officers allowed the few sworn Dispatchers a chance to take some time off and keep the Police Department up and running.

This is the nerve center for the Department as all calls from citizenry for assistance comes through this office. Multilines phone system, 911 phone system, radio channels to Dispatch Police, Fire Ambulance, from the local law enforcement agencies and volunteer fire fighting services in the county.

The Center is usually staffed by four Dispatchers and a supervisor, per 8-hour shifts. During the personnel shortage, minimum of three and they are working 12-hour shifts.

## **Animal Control**

Animal Control is made up of four officers, a supervisor and a clerk. We began talking with the Best Friends Humane Society to begin evaluating the process the Shelter was operating under.

Though fully staffed at the beginning of the year, this quickly changed with the termination of one officer, the retirement of the Supervisor Marty Martinez, and the resignation of two other officers in a very short period of time. One of the officers that remained had very little experience at Animal Control and we pulled MPO Brice Stacy from the Patrol Division to assist Officer Jacquez in keeping the place up and running. MPO Stacy had previously worked in Animal Control so he was the most capable in going in and assisting.

#### Records Unit

The Records Division falls under the supervision of the Special Units Commander and is made up of three clerks and a Record's Supervisor. This is another role that is often overlooked and taken for granted. There seems to be a constant turnover of people in the Division and has changed the Supervisor a couple of times. These employees have a mass of paperwork as well as computer forms to put in and keep on file. From Traffic Citations. Crash Reports, Warrants, to the everyday reports these employees are kept busy. We thought the electronic/digital age would help with some of the ease of replying to the public's requests for records, but it seems as though it has made it easier to ask for the reports and giving out more information. Although the Division generates revenue from fees for the requested copies, under the digital age the fee is nominal to non-existent.
